## Matt Larkin (WA-08) Research Memo

### **Significant Findings**

### Larkin Embellished His Prosecutorial Experience As An AG Candidate

- ✓ Larkin stated during the campaign that he was a proven prosecutor with experience "on both sides of the mountains" in Pierce and Spokane Counties.
  - ✓ However, Larkin never served as a Prosecutor or Deputy Prosecutor in Spokane County, rather he worked there during the summer as an unpaid "extern."
  - ✓ Additionally, Pierce County prosecutor's office said that Larkin worked there for just 67 days.

# Larkin Focused His Congressional Campaign On Increased Crime In Seattle, Not On Washington's 8<sup>th</sup> Congressional District...

- ✓ Larkin prioritized a public safety message in both his 2020 Washington Attorney General campaign and his 2022 congressional race. His campaign slogan for 2022 was "Make Crime Illegal Again."
  - ✓ Larkin demanded increased funding for Seattle PD due to a 2020 increase in homicides and argued that Seattle City Council's push to defund the police would only exacerbate the problem.
  - ✓ Larkin claimed that in Seattle, crime was effectively legal due to the lack of prosecution.
  - ✓ Larkin claimed leadership in Seattle created a toxic environment for their police, causing officers to leave in droves.

### ... But Larkin Lived In The 1st District, Which Wasn't Even In Seattle

- ✓ Larkin lived in Woodinville, WA, 98072.
  - ✓ Larkin's home was in Washington's 1<sup>st</sup> District, not the 8<sup>th</sup> District.
  - ✓ Neither WA-08 nor WA-01 included any part of Seattle.

### Depending On The Time Or Audience, Larkin Shifted His Stances On Trump, Jan. 6, And The "Big Lie"

✓ Larkin said on a Zoom Republican rally during 2020 AG campaign, "I support everything the president is doing [...] I love that he doesn't care."



- ✓ But during an interview with an editorial board, Larkin said he was "frustrated" with Trump's "bombastic" rhetoric and stated he would have litigated some of the state's lawsuits against the Trump administration.
- ✓ In the immediate aftermath of the U.S. Capitol insurrection on January 6, Larkin condemned the political violence of the day, connecting it to Seattle's violent protests in 2020.
  - ✓ But as a prospective congressional candidate in June 2021, Larkin refused to accept the results of the 2020 presidential election and answer questions about how he would have voted on the creation of a bipartisan commission to investigate the January 6<sup>th</sup> insurrection.
- ✓ Larkin initially declined to comment on Trump's claims of a fraudulent election, but later empathized with "Republicans who are feeling slighted by the last election," agreeing that "there is not a lot of trust in the integrity of the system right now."

### Larkin Held Far-Right Policy Views: Against The ACA, Against Gun Control, And Against Choice

- ✓ Former Washington Attorney General Rob McKenna endorsed Larkin's 2020 campaign. McKenna joined other State AGs in suing over the ACA.
- ✓ Larkin stated he was against Initiative 1639 which limited automatic rifle purchases.
- ✓ Larkin was an anti-abortion extremist that wanted to ban abortion without exceptions for rape or incest and supported federal bans that would threaten access to abortion in Washington.

## Larkin Was The Chief Legal Counsel For Romac Industries, A Company Run By His Father And A Serial **Labor Violator That Received Millions In PPP Loans**

- ✓ Larkin championed small businesses despite being handed the role of Chief Legal Counsel at Romac Industries by his father who runs the business.
- ✓ Romac Industries was subject to 17 OSHA inspections and was fined by OSHA for 19 violations in addition to 16 "Other" violations.
  - ✓ Under Larkin's tenure as Chief Counsel, OSHA fined Romac Industries \$4,200 for failing to protect employees from potentially hazardous energy.
  - ✓ OSHA found that Romac Industries has committed at least 4 violations of failing to guard the operator and employees from the hazards of operating machinery.
- ✓ Under Larkin's tenure as Chief Counsel, Romac Industries settled with a fired employee who filed a complaint detailing among other things: a hostile work environment, disparate treatment, and unlawful retaliation based on race, disability, family with children, reasonable accommodation and FMLA status.



- ✓ Larkin's professional and political lives were inexorably intertwined with donations to his 2020 campaign from himself, family, and Romac Industries employees.
- ✓ Larkin attacked Democrats' "reckless" spending despite Romac Industries receiving \$6,350,000 in PPP loans

### **Larkin Ignored Washington's COVID Protocols**

- ✓ Larkin failed to follow the state's COVID guidelines during his 2020 AG run, attending events that did not follow state protocols.
  - ✓ August 2020: Larkin attended an event that featured hugs and handshakes instead of face masks and social distancing, violating the state's indoor mask requirement.
  - ✓ October 2020: Larkin appeared at rallies with larger crowds than restrictions allowed, and most attendees did not wear masks.

### Larkin Received Endorsements For His 2020 AG Run From State Lawmakers Mired In Controversy

- ✓ Larkin was endorsed by State Senator Doug Ericksen, who received a \$500,000 annual lobbying contract as a registered foreign agent from the authoritarian Cambodian government after praising its electoral process.
  - ✓ Seattle Times Editorial Board demanded Ericksen either cancel the contract or step down as State Senator.
- ✓ Larkin was endorsed by Dino Rossi, former State Senator and 2018 Republican candidate for WA-08, who accepted tens of thousands from lobbyists, and even partnered with lobbyists on a real estate deal.
  - ✓ Politifact: "Did Dino Rossi take away health care coverage from 45,000 children? Mostly True."
- ✓ Three Washington lawmakers (State Senator Luanne Van Werven, State Representative Jesse Young, and former State Senator Mike Padden) endorsed Larkin. All were accused of ethics violations.
  - ✓ Van Werven was disciplined and removed from the Legislative Ethics Board after using taxpayer money to promote her political campaign.
  - ✓ Young was fined for twice in less than a year for mixing campaign work and state resources.
  - ✓ Padden was caught funneling money to a former employer, Valley Empire Collection, by awarding county contracts and crafting special-interests legislation.
- ✓ Three extreme Washington lawmakers (State Representative Jim Walsh, State Representative Robert Sutherland and Former State Senator Mark Miloscia) endorsed Larkin.



- ✓ Walsh compared Washington's COVID-19 vaccine mandates to the Holocaust: "It's an echo from history. In the current context, we're all Jews."
- ✓ Sutherland threatened police officers with "revolution" and called them "goons" at an April 19 protest against the stay-at-home order in Olympia.
- ✓ Miloscia argued people with no religious affiliation have declared "religious war" on "longtime enemies -- faithful Christians, Orthodox Jews and Muslims."

### Larkin Embellished His Prosecutorial Experience During 2020 AG Run

Larkin Advertised Prosecutorial Experience In Spokane And Pierce Counties, Despite Working As An Unpaid "Extern" In Spokane County And Working For Only 67 Days In Pierce County.

Larkin Stated On The Campaign Trail That He Had Experience Prosecuting On Both Sides Of The Mountains In Pierce And Spokane Counties. "I was a criminal prosecutor in Pierce County. I have also been a criminal prosecutor in Spokane County. So, I have prosecuted on both sides of the mountains." [Facebook, Chris Leyba for Washington State Auditor, 31:12, 9/6/20]

**Larkin Exaggerated His Prosecutorial Experience In Spokane County, Working Only As An Unpaid** "Extern." "Larkin served as student volunteer known as an 'extern' in the Spokane County prosecutor's office while at Gonzaga, so he would have needed supervision by an attorney [...] Larkin defended the description, saying he did some courtroom work by himself as a Gonzaga extern and mentioned his supervisor, Brian O'Brien. O'Brien said later he had no specific recollection of Larkin's work." [Spokesman-Review (Spokane), 10/8/20]

## Larkin Focused His 2022 Campaign On Crime In Seattle, Calling Crime "Effectively Legal"

Larkin Unveiled Campaign Slogan For 2022 Election: "Make Crime Illegal Again." "There is an astounding failure of left-wing prosecutors to pursue charges against criminals and it makes us all unsafe. They refuse to prosecute crime, and I'm running on a platform to make crime illegal again' [...] When asked about the rioters in Seattle and in Portland, Oregon, over last summer -- many who attacked courthouses, assaulted police officers and have gone without trials -- Larkin called it a problem, but said he is 'not surprised.' He said that 89% of arrests for all crimes in the city of Seattle go without any resolution. Violent crime, including murders and kidnappings, has significantly gone up in Seattle over the last few years. Larkin specifically pointed to troubling statistics revealing that the frequency of human trafficking incidents in Washington state have increased nearly 2,000% over the last few years." After Launching His Campaign In May 2021, Larkin Responded To Calls To Defund the Police By Advocating For Further Funding And Support For Seattle Police. "Support for funding the police, not defunding or stripping away resources, is also close to Larkin's heart. Larkin said that especially over the summer, law enforcement officers were being abused by rioters who were 'literally trying to burn them alive in precincts across Seattle [...] They threw a flaming spear into the window of an occupied police car and tried to burn the officer alive. These things are real, these are not stories for dramatic effect, these things are really happening, [...] Law enforcement needs our help, especially since Seattle is still slashing the police budget [...] When crime is skyrocketing, that is not the time to cut your law enforcement budget. It is going to exacerbate the problem." [Fox News, 5/22/21]

Larkin: "In Seattle, Crime Is Effectively Legal Due To The Lack Of Prosecution." "We can't continue like this. In Seattle, crime is effectively legal due to lack of prosecution, and innocent people are paying the price in the streets. Our leaders are turning a blind eye as crime has spiraled out of control." Larkin Called For Support For Seattle Police: "Leadership In Seattle Has Created A Toxic Environment For Seattle PD." "Brandi says it best. Elected officials should not be held to a special, lower standard. Leadership in Seattle has created a toxic environment for Seattle PD, and they are now leaving in droves." Larkin: "Washington Supreme Court Has Effectively Legalized Felony Drug Possession." "The Washington Supreme Court has effectively legalized felony drug possession. This is reckless and will harm those communities and individuals that need help the most. King County And Seattle Experimented With No Jailtime And Restitution For Felonies Committed By First Time Criminals. "Juveniles and adults accused of a first-time, non-violent felony offense will be offered an alternative where a non-profit community panel will decide how the accused person can be held accountable for their crime. [...] Accountability would not include jail or even a conviction [...] 'That's up to



the community groups' [...] adding that it would target 800 juveniles and 1,000 adults to start. 'These are low-level felonies, property offenses, no domestic violence, no sexual assault cases (and) decisions you would make if you were in my shoes.'" [KOMO News, 11/17/20]

Larkin Said Next Washington AG Should Focus On Issues Of Crime And Violence In Seattle Over National Issues. "Matt Larkin, Ferguson's Republican challenger, would like voters to focus on other images — of crime, drug use and violent clashes between protesters and police in Seattle. The first-time candidate, who works for his family's manufacturing business, says Ferguson has been far too focused on Trump and national politics while neglecting problems closer to home." **Larkin Disagreed With AG Ferguson's Number Of Lawsuits Against President Trump And Demanded Focus On Crime In The State**. "80 lawsuits against a sitting president is a lot [...] We should not be sending that much time and focus on Washington DC [...] There were plenty I would not have pursued. There were some on ceiling fan emissions, there was one against noise pollution in the US Navy Base in Whidbey Island. Those are things that can be left for other times in other states and other people to deal with. Again, we have real problems here. 

"A company created by state Sen. Doug Ericksen has landed a \$500,000 lobbying contract from the Cambodian government he praised last year during a controversial visit as an election observer.
